

#### Dear colleagues,

It is a great pleasure to write this editorial on the occasion of the restart of the PADDLE project. Collaboration will finally resume and allow us to have the face-to-face exchanges that are the purpose of this project.

The impact of the pandemic on our project has been very important. Mobilities were completely stopped for a year and a half and the conditions of exchanges delayed many deliverables.

Fortunately, thanks to exchanges with the European Agency, we were able to extend the project by several months. For the moment the project is officially extended until 31 December 2022, but in agreement with our Project Officer we have decided to extend it until 30 April 2023. This will allow us to carry out our mobilities and finalise all our deliverables as initially planned.

Many of you set off again as soon as the project resumed and, as of May 2022, 15 secondments have already been completed.

You will see in this letter that several publications have been accepted. They allow us to promote and share the results of our research during the months of mobility. The last interdisciplinary workshop allowed us to train Senegalese parliamentarians on the complexity of the marine spatial planning process.

In a few weeks, the call for papers for our final conference to be held in Brest from 4 to 6 April 2023 will be published. This will be an opportunity to get together around the theme of MSP in the tropics, a subject on which we have all been investing, to celebrate our collaboration and to imagine new projects.

# REMINDERG

#### Important things to remember about your publications

nformation on every publication will be uploaded on the European portal.

- For them to be recorded, the following sentence must be present on all documents related to the PADDLE project: "This project has received funding from the European Union's Horizon 2020 research and innovation programme under Grant Agreement No 734271".
- It is imperative to send the exact references of your publications to paddle@ird.fr. IRD will set up a procedure to reference your publications and upload them to the EU portal, taking into account publishers' embargoes.
- It is also crucial to inform us on the communications made in colloquims / workshops in relation with the PADDLE project, in order to mention them in the project's scientific reports and website. You can decide whether or not you would like to put the presentation on the project's website. It could be immediately done, or after a defined embargo.
- Tip: To make our publications more visible, we could put « Paddle Project » as a keyword

#### Secondment check-list

#### **Prior to your secondment**

- ✓ check your secondment eligibility (cf. Art. 6.2, Grant Agreement)
- ✓ Send an email to paddle@ird.fr to Exchange with the project coordinator and manager about your planned secondments
- ✓ Complete and sign the risk assessment form
- ✓ Communicate with your WP leader who is going where and when by adding a post on the padlet (see Reminder on communication below)

#### At the end of your secondment

- ✓ Fill in the attestation of secondment form, detailing the work packages and tasks you have been working on and submit it to the project coordinator and to
- ✓ Upload your secondment on the EU portal
- ✓ Send photos to the project team to feed in the project website

#### Adding a secondment on the EU portal

#### Behind the algorithms, a mysterious logic

- The EU portal counts the duration of secondments based on a mysterious logic (algorithms, useless to try to understand). Based on the idea that one secondment = 30 days mission, you should enter your planned secondment as a draft prior to taking plane tickets, to check the portal's count. If needed (0,97 secondment counted instead of 1), you can then adapt your travel dates.
- Reminder: the dates that count are those of your departure and return to your home town.

#### **Optimizing secondment counting**

- Reminder: a "secondment" is a 30-days mission in one partner university for one researcher.
- If a researcher goes several times on mission to the same partner institution and works on the same WPs, these missions can add up. This is achieved only if they are uploaded on the EU portal on a single line thanks to the button "add a period" (for more details, see the guide on the project website).
- Example:

30-07-2017 (1-10-2017 Full Time 18-04-2018 28-04-2018 Full Time 16-10-2018 16-10-2018 Full Time

If you have not done so, the missions won't add up... triggering less payment from EU than expected!

#### **Needed secondments in WP5**

Very few secondments have been added in WP5 since the start of the project, whereas many had been announced. You can declare several secondments for a single WP, do not hesitate to do so! WP5 is involved on interdisciplinary approaches to MSP. Sophie Bertrand (sophie. bertrand@ird.fr) is the Workpackage leader, don't hesitate to contact her on this purpose.

#### 2 new partners in the consortium

#### **UTA/Cabo Verde**

In Cape Verde, institutions related to marine science have evolved. Several of our colleagues are now part of a new structure called UTA Atlantic Technical University.





The objective of the UTA is to promote training by contributing to the social and economic development of the country and the region and to the knowledge, defence and dissemination of its natural and cultural heritage, as well as providing services to the community. Among the teaching and research units of the UTA, the «Institute of Engineering and Marine Sciences», located on the island of São Vicente, will allow many exchanges with the members of the PADDLE project, both from a research and a pedagogical point of view.



#### Universidade federal de Santa Catarina (UFSC)

In Brazil, 3 partners have developed relationships with the Universidade Federal de Santa Catarina de Florianopolis in relation to the research conducted by this university.

The Integrated Coastal Zone Management Laboratory is now part of the Consortium and months of mobility are already planned



#### DAKAR



The training workshop for parliamentarians on «Offshore development of human activities: issues and challenges in Senegal» was held on Thursday 28 April 2022 at the Finance Committee of the National Assembly. About twenty parliamentarians and members of the Network of Parliamentarians for the Environment of Senegal (REPES), mainly composed of REPES members of parliament, members of the Economic, Social and Environmental Council (CESE) and members of the Union of Associations of Local Elected Officials participated in this workshop co-organised by REPES, UCAD and IRD.

This workshop contributed to strengthening the forward thinking and anticipation skills of parliamentarians on marine spatial planning.

The workshop was divided into two parts. The first part of the morning was devoted to presentations by the academic partners on the issues at stake in MSP, and on the challenges and opportunities of marine spatial planning for Senegal. These first presentations were completed by a presentation on the importance of research and scientific data for organising human activities at sea and by the presentation of the Cartographic Atlas of Marine Environmental Law which was produced in the framework of the H2020-MSCA-RISE PADDLE project.

The parliamentarians then experimented with marine spatial planning through the simulation game «Marine Spatial Challenge». This experience allowed them to measure the complexity of the process, the links between MSP and public policies and the importance of interdisciplinarity in this policy area.

It will take place in Brest.




